About converting a foreign driver's license	If you have a valid driver's license that was issued in a foreign country, you can apply for a Japanese driver's license that allows you to drive in Japan with your foreign license.

	②Knowledge and driving skill check (Make appointment for a later date)
	↓ ③Passing the aptitude test (eyesight test, etc.)

Application conditions	If you go through the procedure at the Miyagi Prefecture Driver's License Center, you need to satisfy the all of the
	following conditions. ①You have a valid foreign driver's license.
	②After receiving a license in a foreign country, you stayed in that country for a total period of three months or more.
	③You are registered as a resident of Miyagi Prefecture. (You may be asked to submit materials that verify that you are living in Miyagi, such as a health insurance card, apartment contract or utility bill receipt, etc.)

	We will check your period of stay in the country you obtained your license in after the license was issued to see if your stay was three months or longer, but if we can't confirm your immigration history, please be prepared to provide various documents for us to check (certificate of graduation, certificate of employment, certificate of tax payment etc).
	One photograph (length $3 \times$ width 2.4 cm, showing your full face, no hat, blank background, above chest, taken within the past six months before application, <u>without your teeth showing</u>)
	Japanese driver's license (Only necessary for those who have/have previously held a Japanese driver's license)
	<u>% In addition to the above, additional documents may be required depending on the country in which the license</u> was obtained.
Others	After the document review is completed, we will conduct the aptitude test, knowledge and driving skill check on a separate day.
	The knowledge and driving skill check is by appointment only, so it can't be done on the day you first apply.
	For the following 29 countries and regions, the knowledge and driving skill check will be exempted and only an aptitude test will be conducted after checking all documents, and a driver's license will be issued after passing the test.
